## RESERVATIONS

1. **Contract Deadline is August 1, 2021.**

## DISPLAYS

1. All breweries are limited to the space assigned by the Columbiana Craft Beerfest Committee.
2. NO Sales other than those described on F4 State Permit and on the Contract are permitted. Breweries are not permitted to sell or give away food.
3. All tasting pours are limited to 5 oz – NO EXCEPTIONS!
4. Breweries are asked to bring no more than (6) different beers as permitted by law to sell at their breweries. Breweries will be reimbursed by a pre-set cost for all tapped kegs.
5. **Set-up Time:** Saturday, October 9, 2021, 12:00 PM – 2:00 PM. **You must be setup and ready to serve no later than 45 minutes prior to opening.**
6. Breweries are responsibility for remove of their trash after the event.

## RESTRICTIONS

1. The applicant (lessee) hereby covenants to indemnify and save the Restoration and Beautification Committee of Columbiana, and Town Center at Firestone Farms (lessor) harmless from and against any and all liabilities, claims, damages, actions, causes of actions and attorney fees and court costs associated therewith, arising from injury during the subject event to person or property occasioned wholly or in party by any act of omission of the applicant (lessee) or guest, servant, agent or employee of the applicant (lessee); and this indemnification agreement shall remain in effect form the time of the applicant (lessee) brings his or her display into the City limits to the time at which he or she removes the same from the City Limits.
2. Lessor shall not be responsible for any injury that may arise of come to lessee or their employee or their goods from any cause whatsoever while on said premises and being occupied under this agreement.
3. Columbiana Craft BeerFest Committee shall have full power to make such rules and regulations as it may deem advisable and may amend same at any time.
4. Lessee/Lessor serving alcohol may NOT serve alcohol to minors. Lessee/Lessor is also responsible to refuse to serve customers that appear overly intoxicated.
5. *Breweries will submit a copy of alcohol license and proof of insurance by the contact deadline (August 1, 2021).*
6. **Please NOTE:** All participants are required to adhere to the CDC, State and Local Health Department Covid-19 guidelines for their type of business and are responsible for the sanitizing their areas hourly. Columbiana Craft BeerFest Committee volunteers will be maintaining common areas and are available should you need assistance.

## Equipment, supplies, and services provided by Columbiana Craft Beerfest Committee (CCBC)

1. Tasting-size (5oz) and full-size (14oz) beer cups.
2. Pourers (2) for each brewery.
3. 1 table and 2 chairs for each brewer.
4. Tasting sample cards and full-size beer tickets (sales/money handling).
5. Bus Tub for dumping product.
6. 2 pitchers and water to rinse out tasting cups.
7. Electricity hook up – upon request. Electric is available on a limited range.

## Equipment, supplies, and services provided by brewery

1. At least 1 volunteer to assist with pourers and customers.
2. Attire designating the vendor/brand you represent.
3. Signage for your designated space.
4. Tent/overhead covering branded or otherwise (please consider space limitations of venue); branded table cloth or runner.
5. Equipment needed to properly distribute your product (coolers, kegs, taps, bins/tubs for kegs/ice).
6. Ice needed to chill and serve your product.
